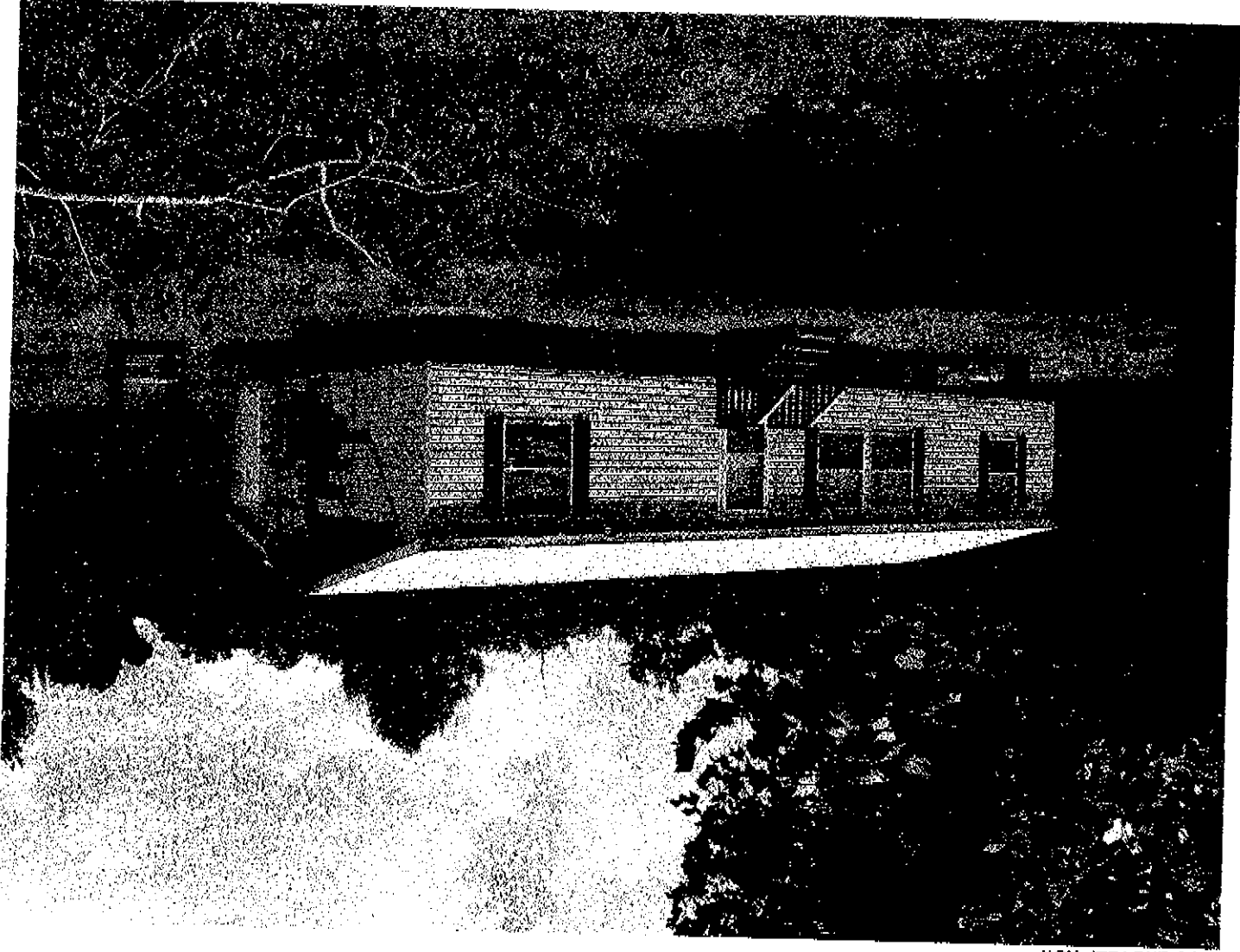

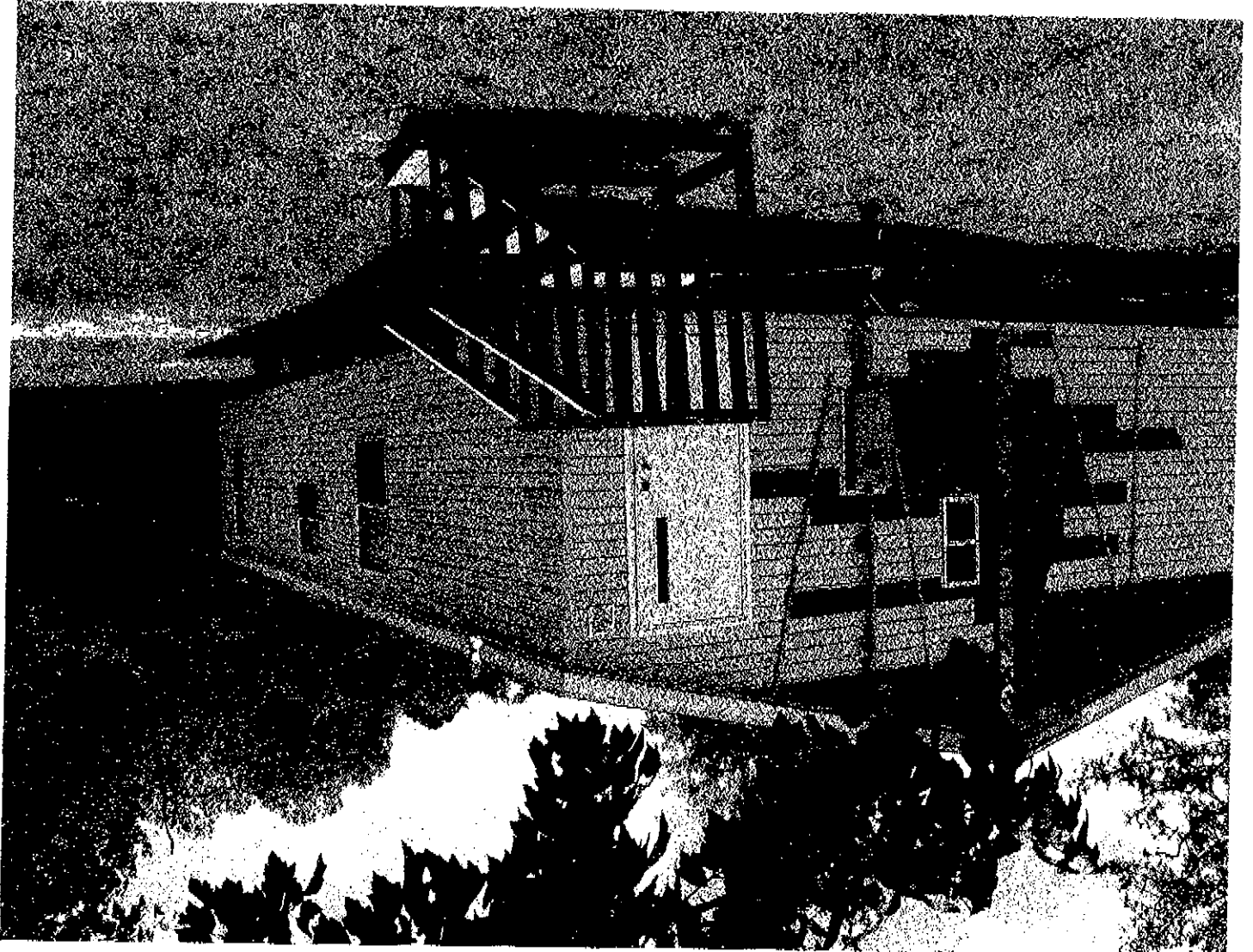


Side and rear view
