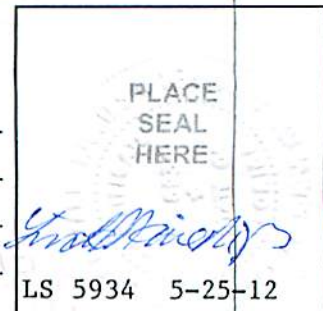

FIRM12005C0461H became effective 6-2-09, however, the prior FIRM is being used for grandfathering purposes because the building was under construction at the time the new FIRM became effective. This building lies in Flood Zone AE (EL 9) on FIRM 12005C0461H. The base flood elevations on FIRM 12005C0461H are referenced to NAVD 1988. The elevation of the bottom of the elevator shaft is 9.5 feet (NGVD 1929). The exterior generator pad elevation is 10.0 feet (NGVD 1929).
