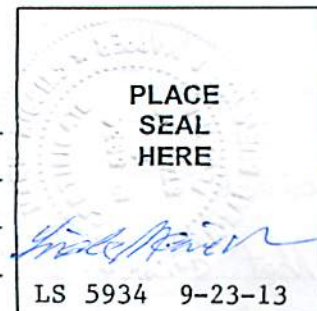

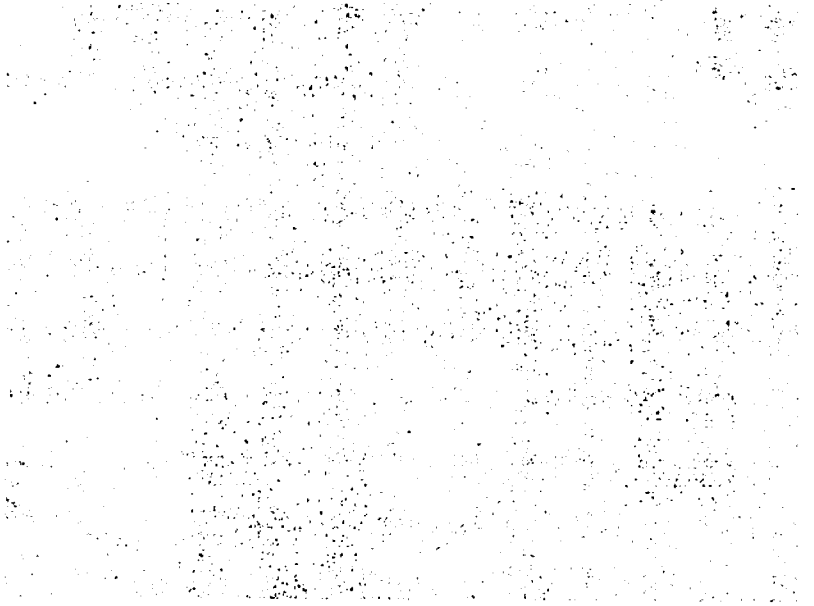

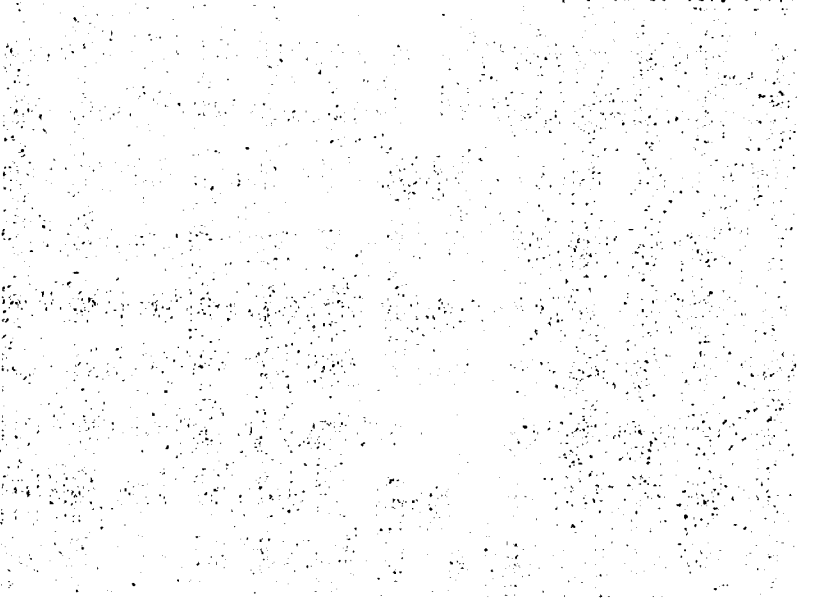

We have reviewed your recent application for a permit to improve your existing building at 800 Pinecrest Avenue, Panama City, Florida 32401. The structure is in a Special Flood Hazard Area AE-8 but is not considered a Substantial Improvement because they are not improving past the 50%. However for the City of Panama City records we need an original Elevation Certificate with the actual sign and seal and a cost of the improvements. If within the next five years they want to add any more improvements we need to make sure it does not pass the 50% then it will be a substantial improvement if it does.
