Per the City of Lynn Haven, ordinance 20-12, section 14.28, the minimum requirement for new construction states the lowest floor elevation of a new structure must be at least 1.0 foot above the center line of the road. Per the City of Lynn Haven, Preliminary FEMA J Series Maps were adopted in January 2022 by the city council. Current FEMA elevation for this parcel is 7.0 feet, the new J Series FEMA Maps (not effective as of the signers date) denote 9.0 feet. The center line of the road elevation is 5.3 feet. 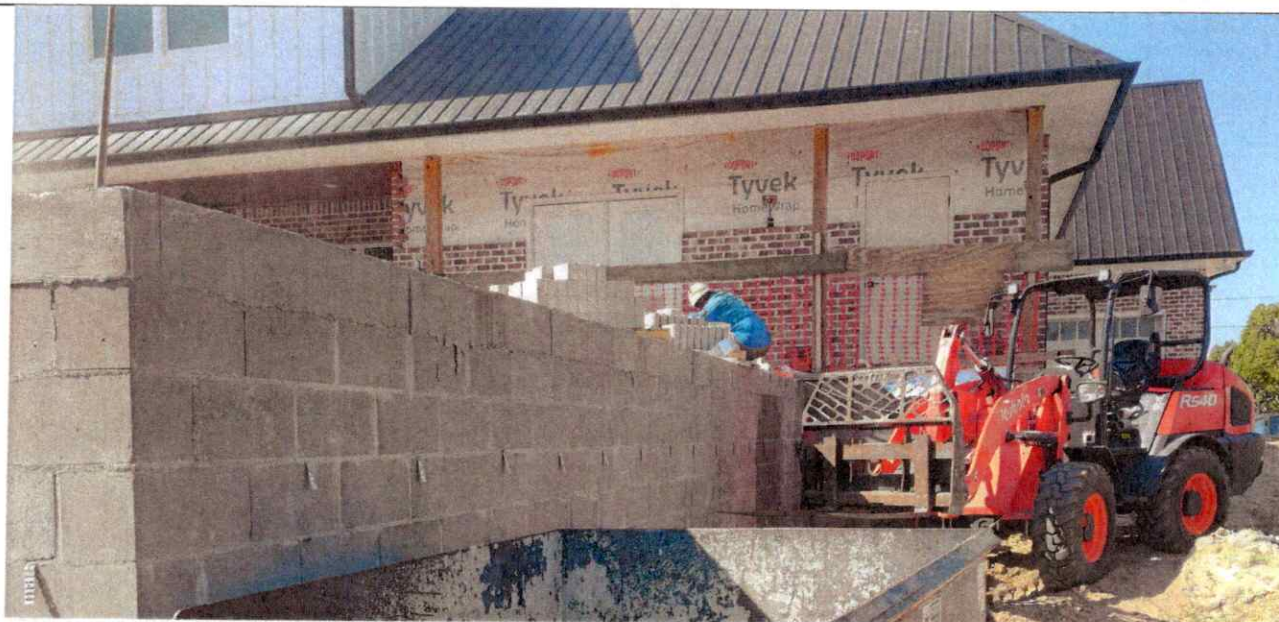
