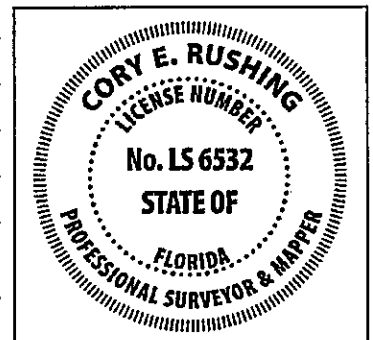

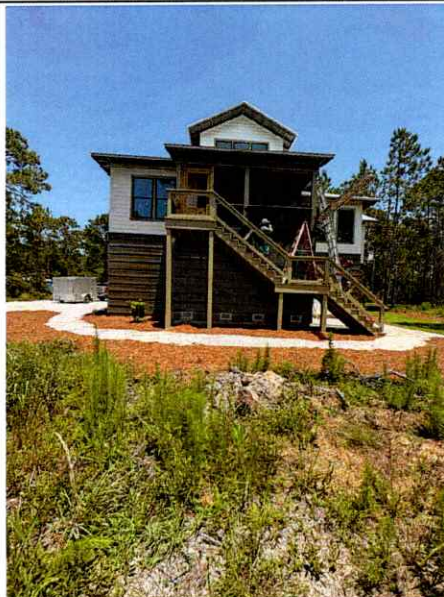

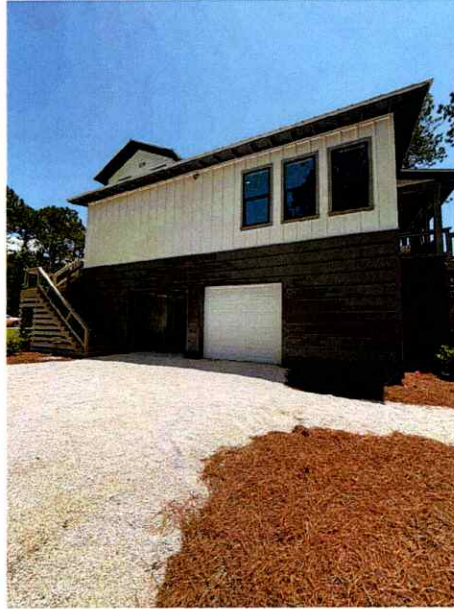

Photo Three Caption: Right Side View 05/20/2026

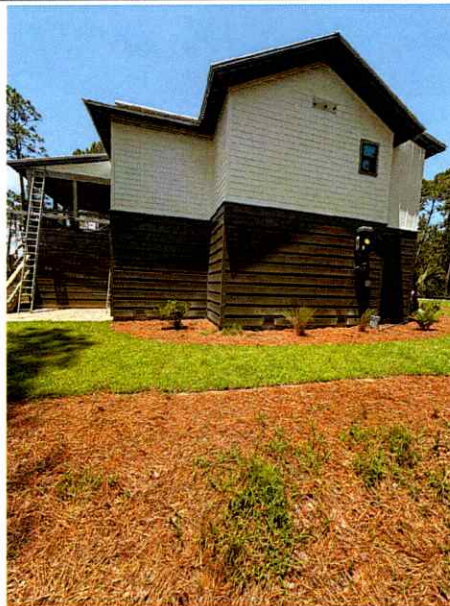
